Withholding periods:

Livestock that have been grazing on or fed cotton gin trash should be placed on clean feed for 60 days prior to slaughter.

Jurisdiction:

NSW and Qld only.

Additional Conditions:

The purpose of this permit is to omit users from the restraint prohibiting the feeding of livestock with cotton gin trash treated with the listed products. Feeding to livestock would be permitted, provided that clean feed is provided for a minimum of 60 days prior to slaughter.

This Permit provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit.
